An application fee of Rs 500.00 per vehicle for General Public by means of a Demand Draft (DD) or pay Order in favour of Central Bank of India payable at Bhopal must be submitted along with the Bid.

Application fee is not charged for Staff and Ex-Staff. Alternatively, the forms can be downloaded from the Bank's website www.centralbank.bank.in under "Tender Section".

3. OPENING OF TENDERS & VALIDITY PERIOD: The bids are to be submitted by 1500 Hrs on or before 16 June 2026. Bids will be opened on 16 June 2026 at 1530 Hrs.

The interested tenderers may remain present during the offer opening process at the scheduled date and time. The offer will be valid for a period of two (02) months from the date of receipt of offer by successful bidder to enable the office for observing all necessary formalities.

4. INSPECTION OF VEHICLE: Interested tenderers may inspect the vehicle with permission at Central Bank of India, Zonal Office

at the said address from 25 May 2026 to 05 June 2026, 1000 Hrs to 1600 Hrs (excluding Bank holidays).

5. The Bid Must Be Submitted in an Envelope That Must Be Super Scribed As **"BID FOR PURCHASE OF VEHICLE REGISTRATION NOMP-15 CB-2624 (TATA Indigo ECS)."**

6. Earnest Money Deposit (EMD) of Rs **10,000.00** (Rupees Ten Thousand only) for General public and Rs **5000.00** (Rupees Five Thousand only) for Staff and Ex-Staff shall be paid along with the offer.

The DDs/Pay Orders for application (as mentioned in Para 1 above) and EMDs must be enclosed with the Bid. DD should be in favour of Central Bank of India payable at Bhopal.

The successful bidder has to pay the full amount **and applicable GST amount additional** for vehicle less amount of EMD for vehicle within seven (07) working days from the date of receipt of intimation (Excluding) by means of DD/Pay Order favoring central Bank of India and payable at Bhopal. Failure to make payment of the full amount plus applicable GST in time may result in forfeiture of the offer to purchase the vehicle as well as the EMD submitted. Application forms without application fee or EMD will be rejected. Presence of respondents during the opening of tender on the appointed date and time will be allowed and they will be informed about the same through letter or email.

7. In case of no response from H 1 bidder or if the H 1 bidder refuses to accept the vehicle due to any reason, the EMD shall be forfeited and offer will be extended to the H 2 bidder (H 2 to match the rate of H 1. Similar procedure shall be followed in respect of H2/H3 etc. as long as the Bank is able to get a price above the Reserve Price. Vehicle shall not be disposed off below the Reserve Price.

8. Terms and Conditions:

a) The Vehicle is sold on **"As is Where is"** basis only.

b) The successful H 1 bidder will be required to deposit the balance bid amount **and applicable GST amount additional** after deducting the Earnest money Deposit (EMD) as mentioned above within 7 days. If no response is received from the highest bidder, his earnest money shall be forfeited and the offer will be extended to second highest bidder.

c) The delivery of the sold vehicle will be given only after the transfer of registration of the purchaser and appearance of

his/her name on the NOC as the new owner and verification of KYC documents by Bank. Transfer of insurance in the name of the successful bidder will also be ensured. In case of "Insurance Transfer", proportionate balance premium will be recovered from the successful bidder. Format for submission of Application is attached as Annexure respectively with this tender notice. The Bidder must submit the documents required to be submitted along with the bid to avoid rejection of application.

d) The sold vehicle shall have to be removed by the successful bidder at his own expenses.

e) The successful bidder will be responsible for getting the Registration Certificate of the vehicle transferred in his name and at his cost expeditiously. Xerox copy of the RC & related documents to be given to the Bank.

f) The vehicle will be transferred strictly in the name of the bidder or owner/proprietor/Partner of the bidding firm only. Request to transfer the vehicle in any third party will not be entertained in any condition.

g) Approval of sale offer is subject to Bank's internal procedure and as such participating bidders have no right to claim interest on the Earnest Money deposited by them with the Bid/Quotation/sale offers.

h) The Bidder has to sign each page of all the offer papers being submitted.

i) The Bank (Central Bank of India) reserves the right to accept/reject any tender without assigning any reason and our decision in case of doubt/dispute shall be final and binding on both the parties.

j) Bank will be discharged from its liability from the date of sale of vehicle.

k) In case of any dispute, jurisdiction will be restricted to Bhopal only.
