Empanelment of Contractor for Supply, Installation and Maintenance of SS-304 Stainless Steel Tactile Ground Surface Indicators (TGSi) at Branches under Regional Office, Ludhiana on Rate Contract Basis

1. Objective:- Central Bank of India, Regional Office-Ludhiana having a network of **52/36/01 Branches/ATM/Offices** spanning with in States/Districts (Attached List of Branches/Offices) invites sealed/tenders from eligible agencies for empanelment on a Rate Contract Basis for supply and installation of SS-304 Tactile Ground Surface Indicators (Directional & Warning Type) at various branches under our jurisdiction to improve accessibility for Persons with Disabilities. The contract shall remain valid for minimum 01year (extendable by one year on satisfactory performance).

2. Scope of Work:-The successful bidder shall execute the following works at any Branch/Office under the jurisdiction of the Regional Office:

- Supply and installation of SS-304 Directional Tactile Indicators.
- Supply and installation of SS-304 Warning (Stud Type) Tactile Indicators.
- Surface preparation before installation.
- Drilling, fixing with heavy-duty epoxy adhesive and/or SS anchor pins.
- Alignment, cleaning and finishing.
- Replacement of defective tactile indicators during the Defect Liability Period.
- Transportation, labour, loading/unloading and all incidental charges.

The Bank reserves the right to increase or decrease the number of branches and quantities without assigning any reason.

3. Area of Operation:- The contractor shall undertake work at all existing and future branches/offices under Regional Office as per attached.

7. Defect Liability Period:- 12 Months from completion. Any loose, damaged or detached tactile indicators shall be replaced free of cost.

8. Eligibility:- GST Registration, PAN, ITR, experience in similar works, Experience with Banks/PSUs/Government organizations preferred, firm should not be blacklisted with any organisation (**Central Bank of India may contact other organisations which have issued the work orders to the bidder**).

9. Terms & Conditions

The Bank may add or delete branches during the contract period.

The contractor shall execute work at any branch within the Region at the approved rates.

Rates shall remain valid throughout the contract period.

The Bank is under no obligation to award any minimum value of work.

Branch-wise measurements shall be verified jointly before payment.
