RECRUITMENT PROCESS FOR SELECTION OF OFFICERS IN SPECIALIST CATEGORY FOR INFORMATION TECHNOLOGY, RISK MANAGEMENT & TAXATION/CA STREAM ON REGULAR BASIS - DECLARATION OF THE INTERVIEW SCHEDULE

Attention is drawn to our notification dated 23.06.2026 wherein the result of written test as well as the list of provisionally shortlisted candidates to appear for interview was declared for the **Recruitment Process for Selection Of Officers in Specialist Category for Information Technology, Risk Management & Taxation/CA Stream on Regular Basis**. Subsequently, candidates were advised to select the center choice for the Interview. We are now pleased to inform that the interviews of these candidates are scheduled on **August 4, 2026, August 5, 2026, August 6, 2026, August 7, 2026, and August 10, 2026**, from allotted Interview Centers.

Please note that the interview will commence from 09:30 AM onwards, therefore all provisionally shortlisted candidates are advised to report at their allotted Interview center at 08:30 AM on the scheduled date.

The list of candidates along with the allotted Interview Centre is attached as **Annexure A**. The address and point of contact of Interview Centre is attached as **Annexure B**.

The link to download the call letter for interview shall be provided shortly.

It is advised to carry original as well as photocopy of KYC documents (PAN, Aadhar, Passport, Driving License etc.), original call letter for interview and all other relevant documents i.e. certificate of educational qualification, work experience, NOC from current employer, caste certificate, disability certificate if applicable, and any other document required as per Bank's notification dated 28.02.2026 along with four passport size colour photographs to the interview center for verification by the Bank official.

It is once again advised to check if provisionally shortlisted candidates are fulfilling eligibility criteria as per notification dated 28.02.2026 in all respects. Bank reserves the right to disqualify any candidate who does not fulfill the eligibility criteria at any point of time.

All announcements/addendum/ corrigendum/ details pertaining to this process will be only published on the Bank's website www.centralbank.bank.in from time to time under Recruitment section.

Candidates are advised to regularly visit the Bank's website for updates/notices/instructions.

No separate communication/ intimation will be sent to the candidates who are not selected/ shortlisted in the process. All notification/ communication placed on Bank's website shall be treated as an intimation to all candidates who have applied for the process.
