RECRUITMENT OF FOREIGN EXCHANGE OFFICER IN SCALE-III ON REGULAR BASIS - INTERVIEW SCHEDULE

Attention is drawn to our notification dated 08.04.2026 wherein the list of candidates who have qualified online test and provisionally shortlisted to appear for interview for the post of Foreign Exchange Officer Scale III was declared. Further vide our notification dated 13.04.2026, candidates were provided link to select the center as per their choice.

We are now pleased to inform that the interview for the provisionally shortlisted candidates is scheduled to be held virtually on 23rd, 24th, and 27th April 2026. All candidates are advised to report at the allotted interview center at 9.00 AM on scheduled dates.

Candidates are advised to carry original as well as photocopy of KYC Documents (PAN, Aadhar, Passport, Driving License etc.), original call letter for interview and all other relevant documents i.e. certificate of educational qualification/work experience / NOC from current employer to interview center for verification for Bank official/ Caste certificate/ Disability certificate if applicable, and any other document required as per Bank's Notification dated 19.01.2026 along with 4 passport size colour photographs.

Candidates are advised once again to check if they are fulfilling eligibility criteria as per notifications in all respects. Bank reserves the right to disqualify any candidate who does not fulfill the eligibility criteria at any point of time.

It is reiterated that candidates should regularly visit the Bank's website for updates/ notices/ instructions. All announcements/addendum/ corrigendum/ details pertaining to this process will be only published / provided on authorized Bank's website www.centralbank.bank.in from time to time under Recruitment section.
