

TERMS AND CONDITIONS OF SALE

 3. Auction / bidding shall only be through "online electronic mode" through the website of the Service Provider i.e., <https://ibapi.in> on 22-09-2022 from 12.30 PM TO EVENING 4.30 PM

 10. Online auction sale will start automatically on and at the time as mentioned above. Auction/ bidding will initially be for a period of 4 HOURS with auto extension of 10 minutes each till the sale is concluded.
 11. The property "SHALL NOT BE SOLD" below the Reserve Price.
 12. The Authorized Officer is not bound to accept the highest bid or any or all bids and reserves the right to accept or reject any or all the bids or cancel, postpone the e-auction without assigning any reason there-of.
 13. **The successful bidder should deposit 25% of the bid amount (including EMD) within 24hours on declaring him as successful bidder and the balance 75% of the bid amount within 15 days from the date of confirmation of sale by the secured creditor. All deposit and payment shall be in the prescribed mode of payment.**
 14. EMD of unsuccessful bidders will be returned through NEFT/RTGS by the service provider www.ibapi.in to the bank accounts details provided by them at the time of registration.
